**PASAR OTOMOTIF INDONESIA** diperkirakan masih akan terus tumbuh terdorong oleh kondisi ekonomi makro Indonesia yang semakin kondusif. Laju inflasi yang rendah dan peningkatan pendapatan masyarakat serta cenderung makin kompetitifnya pasar jasa transportasi ikut mendorong pertumbuhan pemanfaatan layanan jasa transportasi secara umum.

Pada tahun 2006 misalnya, produksi jenis kendaraan roda empat atau lebih adalah sebesar 296.008 unit melonjak menjadi 702.508 unit dan selama periode Januari – September 2011, produksinya sudah mencapai 612.645 unit dan sampai penghujung tahun 2011 ini diperkirakan akan lebih dari 800.000 unit.

Di sisi lain, produksi sepeda motor Indonesia selama periode tahun 2006-2010 juga mengalami peningkatan secara signifikan. Pada tahun 2006, produksi sepeda motor Indonesia mencapai 4.458.886 unit.
