The company was originally named P.T. KAWAN LAMA HOME CENTER, it was established in February 1995 with authorized capital of Rp. 2,000,000,000.- issued capital of Rp. 640,000,000.- wholly paid-up. The founders and shareholders are P.T. KAWAN LAMA INTERNUSA and Mr. Kuncoro Wibowo, a Chinese origin Indonesian businessman. In October 1997, the company was renamed to P.T. ACE INDORITEL PERKAKAS. On the same occasion, the authorized capital was increased to Rp. 10,000,000,000.- issued capital to Rp. 7,200,000,000.- wholly paid-up. In August 2001, the company renamed again to P.T. ACE HARDWARE INDONESIA. In December 2005 the authorized capital was raised to Rp. 50,000,000,000 of which Rp. 40,000,000,000 was issued and fully paid up. In September 2007, the company renamed to P.T. ACE HARDWARE INDONESIA Tbk (P.T. AHIT) and concurrently the authorized capital was raised to Rp. 480,000,000,000 of which Rp. 171,500,000,000 was issued and fully paid up. In October 2007 the company was quoted as a public listed company by selling 515,000,000 of its shares to the public at the price Rp 1,00 per share in capital market.

P.T. AHIT is member company of the KAWAN LAMA Group, a large company group in trading and distribution of industrial machinery and technical goods.

P.T. AHIT is engaged in retailer of home improvement and life style products including hardwares, hand/power tools, electrical, plumbing, lawn and garden, cleaning/paint and housewares. P.T. AHIT is a franchise holder of ACE Hardware Corporation, the second largest company in the USA in the field of home improvement products retailer established in 1924. Besides that, the company also made an agreement with Mr. IJEK WIDYA KRESNADI as the brand holder of Kris and Krisbow brands and allowing both brands to be used in all outlets of P.T. AHIT. To support its operation, P.T. AHIT has 45 outlets of ACE HARDWARE spreading in various cities in the country including Jakarta, Tangerang, Bekasi, Cirebon, Bandung, Semarang, Surabaya, Denpasar, Medan, Batam, Balikpapan, Palembang, Pekanbaru, Makasar, Malang and Banjarmasin.

Besides that, the company also engaged in investment holding by controlling 59.99% shares of PT. TOYS GAME INDONESIA (deals with industry and trading).
